A new member Abeykumar performed next. He showed three coloured ribbons and tied the ends of each into three circles. He tossed the three circles into the air and when they came down it was seen that all three circles had joined together to form one large circle. (Similar to rainbow ropes)

The new junior member Jayalal made his first appearance before the members and showed a silk from nowhere, silk off hand, where he tied a silk on a volunteer's hand and pulled it off the hand without causing any damage to the silk or the hand. Next he performed the 'stiff rope'. He performed with miming and it was very good as a beginner.

As the members were getting tired there was a request for our magician and tele drama actor Ajith Fernando to show a part of a drama. He acted out a role from a stage drama he had taken part in. It was a very powerful performance and was appreciated by all members present..

The last performer was VP Rohan who showed a colour changing record/disc passing them through a slatted case and using silks.

Refreshments were served by our Birthday Boys Joy, Gayan and Dinesh. Thereafter, VP Shelton's training class on Silk Magic was held. The proceedings came to an end around 1.00pm.
